

ЗАКЛЮЧЕНИЕ

по результатам рассмотрения возражения

Коллегия в порядке, установленном частью четвертой Гражданского кодекса Российской Федерации, введенной в действие с 1 января 2008 г. Федеральным законом от 18 декабря 2006 г. №031-ФЗ в редакции Федерального закона от 12.03.2014 №35-ФЗ «О внесении изменений в части первую, вторую и четвертую Гражданского кодекса Российской Федерации и отдельные законодательные акты Российской Федерации» (далее – Кодекс), и Правилами рассмотрения и разрешения федеральным органом исполнительной власти по интеллектуальной собственности споров в административном порядке, утвержденными приказом Министерства науки и высшего образования Российской Федерации и Министерства экономического развития Российской Федерации от 30.04.2020 за № 644/261 (далее – Правила ППС), рассмотрела возражение, поступившее 01.03.2024 в Федеральную службу по интеллектуальной собственности (далее – Роспатент), поданное Güntner Group Europe GmbH, Hans-Güntner-Str. 2, 82256 Fürstfeldbruck, Германия (далее – заявитель), на решение Роспатента от 08.11.2023 по знаку по международной регистрации №1675009, при этом установлено следующее.

Регистрация комбинированного знака «**Nitto**» с приоритетом от 20.12.2021 произведена Международным Бюро ВОИС за №1675009 – (1) на имя заявителя в отношении товаров 01-34 и услуг 35-45 классов Международной классификации товаров и услуг (далее – МКТУ), указанных в перечне регистрации.

Роспатентом 08.11.2023 принято решение, согласно которому знаку по международной регистрации №1675009 предоставлена правовая охрана на территории Российской Федерации только в отношении товаров и услуг 01-03, 05-12, 16-21, 24-29, 32, 35, 37, 39-42 классов МКТУ.

В сопроводительном письме от 08.11.2023 экспертизой было указано, что доводы заявителя в отношении мотива отказа в соответствии с пунктом 6(2) статьи 1483 Кодекса для части заявленных товаров и услуг были учтены.

Однако противопоставление по товарному знаку по свидетельству №578200 не снято.

В предварительном решении экспертизой было указано, что в отношении части заявленных товаров 07 класса МКТУ знаку по международной регистрации №1675009 не может быть предоставлена правовая охрана на территории Российской Федерации на основании пункта 3 (2) статьи 1483 Кодекса и статьи 1481 Кодекса,

поскольку знак «**Nitto**» по международной регистрации №1675009 (1)

тождественен с товарным знаком «**Nitto**» по свидетельству №578200 с приоритетом от 23.04.2013 – (2), зарегистрированным на имя заявителя, в отношении товаров 07 класса МКТУ «*машины для фильтрования молока; установки доильные, машины доильные*», которые идентичны товарам 07 класса МКТУ «*milk filtering machines; milking machines*», указанным в перечне знака по международной регистрации №1675009 – (1).

В Роспатент 01.03.2024 поступило возражение, в котором заявитель оспаривает решение Роспатента в части отказа в предоставлении правовой охраны знаку по международной регистрации №1675009 – (1) в отношении части товаров 07 класса МКТУ.

Заявитель отмечает, что 29.01.2024 в Государственный реестр были внесены изменения, касающиеся сокращения перечня товаров и/или услуг, в отношении которых зарегистрирован противопоставленный товарный знак (2), а именно из перечня товаров 07 класса МКТУ исключены товары «*машины для фильтрования молока; установки доильные, машины доильные*», которые были признаны экспертизой идентичными товарам 07 класса МКТУ «*milk filtering machines; milking machines*» международной регистрации (1).

С учетом изложенного заявитель просит отменить решение Роспатента от 08.11.2023 и предоставить правовую охрану на территории Российской Федерации знаку

по международной регистрации №1675009 в отношении заявленных товаров 07 класса МКТУ «*milk filtering machines; milking machines*», а также в отношении товаров и услуг, указанных в решении Роспатента от 08.11.2023.

В подтверждение изложенного заявителем были сведения по товарному знаку по свидетельству №578200 (2) – [1].

Изучив материалы дела и заслушав лиц, участвующих в рассмотрении возражения, коллегия считает доводы возражения убедительными.

С учетом даты (20.12.2021) приоритета знака по международной регистрации №1675009 правовая база для оценки его охраноспособности включает в себя вышеуказанный Кодекс и Правила составления, подачи и рассмотрения документов, являющихся основанием для совершения юридически значимых действий по государственной регистрации товарных знаков, знаков обслуживания, коллективных знаков, утвержденные приказом Министерства экономического развития Российской Федерации от 20.07.2015 № 482, зарегистрированным в Министерстве юстиции Российской Федерации 18.08.2015 за № 38572, введенные в действие 31.08.2015 (далее – Правила).

Согласно пункту 1 статьи 1477 Кодекса на товарный знак, то есть обозначение, служащее для индивидуализации товаров юридических лиц или индивидуальных предпринимателей, признается исключительное право, удостоверяемое свидетельством на товарный знак.

Согласно статье 1479 Кодекса на территории Российской Федерации действует исключительное право на товарный знак, зарегистрированный федеральным органом исполнительной власти по интеллектуальной собственности, а также в других случаях, предусмотренных международным договором Российской Федерации.

Согласно пункту 2 статьи 1481 Кодекса свидетельство на товарный знак удостоверяет приоритет товарного знака и исключительное право на товарный знак в отношении товаров и услуг, указанных в свидетельстве.

В соответствии с пунктом 41 Правил обозначение считается тождественным с другим обозначением (товарным знаком), если оно совпадает с ним во всех

элементах. Обозначение считается сходным до степени смешения с другим обозначением (товарным знаком), если оно ассоциируется с ним в целом, несмотря на их отдельные отличия.

В соответствии с требованиями подпункта 2 пункта 3 статьи 1483 Кодекса не допускается государственная регистрация в качестве товарных знаков обозначений, представляющих собой или содержащих элементы, противоречащие общественным интересам, принципам гуманности и морали.

В соответствии с пунктом 37 Правил при рассмотрении вопроса о противоречии заявленного обозначения общественным интересам, принципам гуманности и морали учитывается, что к таким обозначениям относятся, в частности, неэтично примененная национальная и (или) государственная символика (гербы, флаги, эмблемы), антигосударственные лозунги, слова и изображения непристойного содержания, призывы антигуманного характера, оскорбляющие человеческое достоинство, религиозные чувства верующих, слова, написание которых нарушает правила орфографии.

Знак «**Nitto**» по международной регистрации №1675009 – (1) представляет собой комбинированное обозначение, включающее словесный элемент «Nitto», выполненный буквами латинского алфавита в оригинальной графике.

Правовая охрана на территории Российской Федерации знаку по международной регистрации №1675009 испрашивается в отношении товаров 01-34 и услуг 35-45 классов МКТУ, указанных в перечне регистрации.

Согласно решению Роспатента от 08.11.2023 предоставление правовой охраны

на территории Российской Федерации знаку «**Nitto**» по международной регистрации №1675009 (1) противоречит общественным интересам в связи с наличием у заявителя старшего права на тождественный товарный знак

«**Nitto**» по свидетельству №578200 с приоритетом от 23.04.2013 – (2), зарегистрированный в отношении идентичных товаров 07 класса МКТУ.

Сравнительный анализ показал, что рассматриваемый знак (1) и противопоставленный знак (2) совпадают во всех элементах: словесные элементы тождественны фонетически и семантически и выполнены одинаковым шрифтом.

Сравнение перечней товаров 07 класса МКТУ *«milk filtering machines; milking machines/ машины для фильтрации молока; доильные машины»*, в отношении которых отказано в предоставлении правовой охраны рассматриваемому знаку (1), и товаров 07 класса МКТУ *«машины для фильтрования молока; установки доильные, машины доильные»*, в отношении которых зарегистрирован противопоставленный товарный знак (2), показало, что они идентичны.

Вместе с тем, при анализе материалов дела коллегией были учтены обстоятельства, которые являются основанием для удовлетворения возражения.

К данным обстоятельствам относится следующее.

По заявлению правообладателя сокращен перечень товаров, в отношении которых зарегистрирован противопоставленный товарный знак (2), а именно из перечня товаров 07 класса МКТУ исключены товары *«машины для фильтрования молока; установки доильные, машины доильные»*, то есть те товары, которые были признаны экспертизой идентичными заявленным товарам 07 класса МКТУ *«milk filtering machines; milking machines»*.

Дата внесения записи в Государственный реестр: 29.01.2024.

С учетом изложенного, знак по международной регистрации №1675009 соответствует требованиям пункта 3 (2) статьи 1483 Кодекса и ему может быть предоставлена правовая охрана на территории Российской Федерации в отношении указанных выше товаров 07 класса МКТУ.

Учитывая вышеизложенное, коллегия пришла к выводу о наличии оснований для принятия Роспатентом следующего решения:

удовлетворить возражение, поступившее 01.03.2024, отменить решение Роспатента от 08.11.2023 и предоставить правовую охрану на территории Российской Федерации знаку по международной регистрации №1675009 в отношении следующих товаров и услуг:

01 класс МКТУ - "Chemical products for use in industry, science, photography, as well as in agriculture, horticulture and forestry; unprocessed artificial resins, unprocessed plastics; fire extinguishing and fire prevention compositions; tempering and soldering preparations; materials for tanning leather and animal skins; adhesives for use in industry; putties and other paste fillers; compost, manures, fertilizers; biological preparations for use in industry and science; chemical products; nucleic acid sequences, other than for medical or veterinary purposes; chemical products for supporting the biosynthesis of nucleic acids; polymer beads for use in the biosynthesis of nucleic acids; industrial and scientific chemicals for the treatment of biopolymers, other than for medical and veterinary purposes; dehumidifying agent [filter]; sensitized soldering masks for use in the manufacture of printed circuit boards; ion-exchange resin membranes [chemical preparation]; chemicals for use in the manufacture of membranes; fulling preparations; anti-frothing solutions for batteries; water-softening preparations; detergents for use in manufacturing processes; chemical preparations for scientific use, other than for medical or veterinary use; filtering materials of unprocessed plastics; filtering materials of plant substances; filtering materials of mineral substances; filtering materials of chemical substances; ceramic materials in the nature of particles, used as filtering media; filtering preparations for the beverage industry; chemical products for purifying water; glue and adhesives for industrial use; plastic adhesives for industrial use; adhesives for applying wall coverings; silicones; adhesives for use in the building industry; adhesives for ornamental paving stones; plant growth regulating preparations; fertilizers; ceramic glazings; priming putties; higher fatty acids; minerals not of metal for use in manufacture; chemical compositions for developing photographs; unexposed sensitized photographic films; reagent paper [not intended for medical purposes]; artificial sweeteners; flour and starch intended for industrial purposes; unprocessed plastic materials; plastics [raw materials]; unprocessed resins intended for use in the manufacture of membranes; unprocessed epoxy resins; unprocessed fluorinated resins;
