


**ЗАКЛЮЧЕНИЕ**  
**по результатам рассмотрения возражения заявления**

Коллегия в порядке, установленном частью четвертой Гражданского кодекса Российской Федерации (далее – Кодекс) и Правилами рассмотрения и разрешения федеральным органом исполнительной власти по интеллектуальной собственности споров в административном порядке, утвержденными приказом Министерства науки и высшего образования Российской Федерации и Министерства экономического развития Российской Федерации от 30.04.2020 №644/261, зарегистрированными в Министерстве юстиции Российской Федерации 25.08.2020 за №59454, вступившими в силу 06.09.2020 (далее – Правила ППС), рассмотрела возражение, поступившее 25.03.2021, поданное компанией «FCA GROUP MARKETING S.p.A.», Италия (далее – заявитель), на решение Федеральной службы по интеллектуальной собственности (далее – Роспатент) об отказе в предоставлении правовой охраны на территории Российской Федерации знаку по международной регистрации №1494582, при этом установлено следующее.



Международная регистрация знака «  » с конвенционным приоритетом от 20.12.2018 была произведена Международным бюро Всемирной организации интеллектуальной собственности за №1494582 на имя заявителя в отношении товаров и услуг 09,12, 14, 16, 18, 21, 24, 25, 28, 41 классов МКТУ, указанных в перечне регистрации.

Роспатентом 25.11.2020 принято решение об отказе в предоставлении правовой охраны на территории Российской Федерации знаку по международной регистрации №1494582 в отношении заявленных товаров и услуг.

В предварительном решении Роспатента от 25.03.2020 указано, что знаку не может быть предоставлена правовая охрана на территории Российской Федерации в отношении заявленных товаров и услуг на основании пунктов 1 и 3 статьи 1483 Кодекса.

Отказ мотивирован тем, что знак по международной регистрации №1494582 содержит дату "1910", которая может быть ложной или способной ввести потребителя в заблуждение относительно времени изготовления или продажи заявленных товаров/услуг в связи с неполучением указанным ведомством документов, подтверждающих право владельца использовать эту дату в обозначении в качестве даты производства товаров или услуг. В случае представления указанных документов, элементы «since 1910» могут быть включены как неохраноспособные элементы обозначения.

В федеральный орган исполнительной власти по интеллектуальной собственности 25.03.2021 поступило возражение на решение Роспатента, в котором заявитель прилагает декларацию, подтверждающую правомерность использования даты «1910» в знаке по международной регистрации №1494582.

На основании изложенного заявитель просит отменить решение Роспатента и предоставить правовую охрану на территории Российской Федерации знаку по международной регистрации №1494582 в отношении всех заявленных товаров и услуг, с указанием словесного элемента "since 1910" в качестве неохраняемого элемента обозначения.

К возражению приложена упомянутая выше декларация (1).

Изучив материалы дела и выслушав представителя заявителя, коллегия находит доводы заявителя убедительными.

С учетом даты конвенционного приоритета (20.12.2018) знака по международной регистрации №1494582 правовая база для оценки его охраноспособности на территории Российской Федерации включает в себя Кодекс и Правила составления, подачи и рассмотрения документов, являющихся основанием для совершения юридически значимых действий по государственной регистрации

товарных знаков, знаков обслуживания, коллективных знаков, утвержденные приказом Министерства экономического развития Российской Федерации от 20 июля 2015 г. N 482 (далее - Правила).

В соответствии с требованиями пункта 1 статьи 1483 Кодекса не допускается государственная регистрация в качестве товарных знаков обозначений, не обладающих различительной способностью или состоящих только из элементов, характеризующих товары, в том числе указывающих на их вид, качество, количество, свойство, назначение, ценность, а также на время, место, способ производства или сбыта. Указанные элементы могут быть включены в товарный знак как неохраняемые элементы, если они не занимают в нем доминирующего положения.

Согласно пункту 34 Правил к обозначениям, не обладающим различительной способностью, относятся, в частности, сведения, касающиеся изготовителя товаров или характеризующие товар, весовые соотношения, материал, сырье, из которого изготовлен товар.


В соответствии с пунктом 3 статьи 1483 Кодекса не допускается регистрация в качестве товарных знаков обозначений, представляющих собой или содержащих элементы, в частности, являющиеся ложными или способными ввести в заблуждение потребителя относительно товара либо его изготовителя.

Согласно пункту 37 Правил при рассмотрении вопроса о ложности или способности обозначения ввести потребителя в заблуждение относительно товара или его изготовителя учитывается, что к таким обозначениям относятся, в частности, обозначения, порождающие в сознании потребителя представление об определенном качестве товара, его изготовителе или месте происхождения, которое не соответствует действительности.

В случае если ложным или вводящим в заблуждение является хотя бы один из его элементов обозначения, то обозначение признается ложным или вводящим в заблуждение.

Знак по международной регистрации №1494582 представляет собой



комбинированное обозначение «», содержащее словесный элемент «Alfa Romeo», выполненный оригинальным шрифтом буквами латинского алфавита, под которым расположен изобразительный элемент в виде горизонтальной полосы, разделенной на три цвета – зеленый, белый и красный. Чуть ниже размещены друг под другом элементы «RACING» и «Since 1910». Предоставление правовой охраны знаку на территории Российской Федерации испрашивается в отношении товаров и услуг 09,12, 14, 16, 18, 21, 24, 25, 28, 41 классов МКТУ, указанных в перечне регистрации.

Анализ заявленного комбинированного обозначения показал, что содержащиеся в нем элементы «SINCE 1910», которые в переводе с английского языка на русский язык означают: «с 1910 года, со времени 1910 года» ([www.translate.yandex.ru](http://www.translate.yandex.ru)), являются неохраноспособными элементами обозначения, так как указывают на дату создания компании-заявителя.

Представленные заявителем источники информации (1) позволяют соотнести дату 1910 год, указанную в заявленном обозначении, с датой основания компании-заявителя и датой возникновения знаменитого бренда «Alfa Romeo», производство продукции под которым продолжается уже более ста лет.

Таким образом, основания для вывода о несоответствии элементов «SINCE 1910» заявленного обозначения требованиям пункта 3 статьи 1483 Кодекса отсутствуют.

Заявителем, на заседании коллегии, состоявшемся 19.05.2021, устно выражено согласие на исключение из самостоятельной правовой охраны словесно-цифрового элемента «SINCE 1910» на основании пункта 1 статьи 1483 Кодекса.

Учитывая изложенное, знаку по международной регистрации №1432055 может быть предоставлена правовая охрана на территории Российской Федерации

на имя заявителя в отношении всех заявленных товаров и услуг с указанием элементов «SINCE 1910» в качестве неохраняемых.

Учитывая вышеизложенное, коллегия пришла к выводу о наличии оснований для принятия Роспатентом следующего решения:
